JOB DUTIES AND RESPONSIBILITIES

The Bartender will:

- Mix and serve alcoholic and non-alcoholic drinks for patrons.
- Communicate with guests using clear words, tone and body language at all times.

- Work as part of a team with all BlackRock staff in order to maintain an effective atmosphere and positive service.
- Set up and breakdown stations, ring drink orders immediately, collect money from guests for drinks served, and make change as necessary.
- Abide by cash handling policies of BlackRock Center for the Arts.
- Ensure bar area/concessions is open and closed safely; securely lock any liquor cabinets when not in use.
- Responsibly serve alcohol.

EDUCATION, EXPERIENCE, KNOWLEDGE, AND SKILL REQUIREMENTS:

- Be of legal age to serve liquor according to Maryland state law
- Basic mathematical skills, including money handling, and giving correct change
- Basic reading and computer skills.
- Basic knowledge of beer, wine, and spirits, and be familiar with standard drink recipes
- Excellent communication and organizational skills
- Knowledge of workplace safety procedures
- Exemplify a commitment to BlackRock's mission to bring performing and visual arts experiences to diverse audiences and providing accessible opportunities to engage in the arts.
- Must have current TIPS certification or be able to acquire TIPS certification within 30 calendar days of employment

- Walking and standing during an entire shift.
